

Expression of Interest

Group Mediclaim Insurance Policy for Employees of IIM Raipur

IIM Raipur invites expression of interest from Govt. / PSU Health Insurance Company for renewal of the existing Group Mediclaim Policy under one bid system. A sum of **Rs 5 Lakh** is to be insured for each employee including dependent family members. At present a total of **149 members** will be insured under this policy.

- 1. The Group Mediclaim Policy should consist minimum following features: -
 - (a) Age for coverage in policy should be Day 1 to 80 years to enter in the policy for new entrants. However, members more than 80 years already ensured in existing policy should be covered in new policy.
 - (b) Room Charges should be admissible as mentioned below

1 % of SI per day, Maximum. Rs. 5000/- per day Normal Room :

- ICU 2 % of SI per day, Maximum Rs. 10000/- per day :
- (c) Pre-existing diseases should be covered under the policy.
- (d) First 30 days / specific waiting periods should be waived of.
- (e) No sub-limits or illness wise limit
- (f) Pre and post hospitalization minimum 30 and 60 days respectively
- (g) Maternity Benefit should be covered without any waiting period and subject to payment of Rs. 25,000/- for normal delivery and Rs. 50,000/- for caesarean delivery.
- (h) New-born baby should be covered with mother since birth, upto 3 month and will be added after 3months or at the time of renewal whichever is earlier as a new member.
- (i) Day one covers for New Joinee and their dependents.
- (j) Mid-term inclusion of Existing Employee's newly acquired dependent (Newly Married Spouse/ new born baby/ newly adopted child)
- (k) Corporate buffer of Rs. 10 Lakh must be provided (Restricted to Rs 2 Lakh per family) for special cases referred by IIM Raipur.
- (1) Claim settlement period not exceeding 15 working days after submission of claim.
- (m) Cashless cards / e-cards to all the members should be provided within one month of the start of the insurance cover.
- 2. The Insurance Company should have cashless arrangement with major Hospitals in Raipur. Therefore, list of empanelled hospital in Raipur (C.G.) for cashless hospitalisation must be provided.
- 3. In addition to above, you may also offer other benefits such as Annual health check-up, waiver of all exclusions, provision for second opinion, emergency ambulance service etc. without affecting the premium amount.
- 4. Apart from above, also provide following details: -
 - (a) List of Day Care Procedures
 - (b) Disease, which are not covered under the policy.
 - (c) Charges /Tests / or any other items which are not covered
 - (d) List of clients (preferably from educational institutions) where such group Mediclaim policies are under operation.
 - (n) Brief profile of TPA & their registration details. There should be a dedicated helpline (24x7) from the TPA of Insurance Company available and the contact details of the same should be furnished.

- 5. Details of employees and their dependents along with age and claim history of <u>last three years</u> is enclosed as Annexed-I & II respectively.
- 6. <u>Seal and Sign of each page of the EOI as token of acceptance should be submitted with all requisite</u> <u>necessary documents and with the final offer. Otherwise, your offer will be assumed null and void.</u>
- 7. Interested Govt. / PSU Health Insurance Company are requested to offer your quotation excluding GST for a group of <u>149</u> members considering all the conditions as mentioned above along with break-up of individual employee in a sealed envelope in Envelop A & B type by 22/02/2021 till 03.30 pm and shall be submitted to "The Store & Purchase, IIM Raipur, Atal Nagar, Kurru (Abhanpur), Raipur 493661" through registered post/speed post/courier/in hand etc.
 - i. Envelop 'A' should contain -Seal and sign of each page of the EOI document, a copy GST registration certificate of the Insurance company and other required details as mentioned in the EOI. This sealed envelope should have superscription- **Envelop-A** "Group Mediclaim Insurance Policy for Employees of IIM Raipur".
 - ii. Envelope 'B' should contain only Financial Bid and other details (if mentioned any) in connection with the financial bid part. This sealed envelope should have superscription-**Envelop-B** "Financial bid Part".
 - iii. Put Envelope A and Envelope B in separate sealed covers and put both the sealed cover in one cover addressed to "The Store & Purchase, IIM Raipur, Atal Nagar, Kurru (Abhanpur), Raipur 493661" with superscription on the cover as "Group Mediclaim Insurance Policy for Employees of IIM Raipur ", No. IIMR/EOI /2020-21/18, dated 08.02.2021 and send it so as to reach on or before 03:30 PM. on or before Feb 22, 2021 in the office of CAO, Indian Institute of Management Raipur.
