Goswami, M., Daultani, Y., De, A. (2020). Decision Modeling and Analysis in New Product Development Considering Supply Chain Uncertainties: A Multi-Functional Expert Based Approach. *Expert Systems with Applications*. DOI: https://doi.org/10.1016/j. eswa.2020.114016.

Abstract: Successful new product development projects and extant research literature advocate for inclusion of inputs pertaining to the supply chain at early stages of product development to proactively identify risk averse product design concepts. To this end, we devise an analytical framework to converge upon product design concept(s) that would be associated with lesser supply chain risks, usually function of both technical and commercialization considerations. The high-level and constituent lower-level

Prof. Mohit Goswami Assistant Professor supply chain risks are represented by parent and root nodes respectively within the devised Bayesian network driven research framework. Thereafter, a quantitative measure denoted as SCRI (supply chain risk index) is evolved that yields overall composite risk numbers corresponding to respective design concepts at different risk states. Validation and comparison of the devised method with an extant study illustrates the consistency and reliability of the study. It is found that the risk propensity of a particular design concept is inversely related

to the probabilistic utility of that particular concept. The case of a construction power tool of a global firm is used to demonstrate the methodology. Our research addresses an important future research pathway as argued by Hosseini et al., (2020) that extant research literature is devoid of decision-making frameworks focused on measurement and analysis the propagation of risks on complex networks.

Kumar, A., & **Dash**, **P**. (2020). Changing transmission of monetary policy on disaggregate inflation in India. *Economic Modelling*, *92*, 109-125. DOI: https://doi.org/10.1016/j.econmod.2020.07.016

Abstract: This paper investigates the time-varying effects of monetary policy on aggregate, sectoral, and disaggregate inflation in India from 1997 to 2017 using a large dataset of 439 variables. We find that the effectiveness of a contractionary monetary policy in controlling aggregate inflation has improved over time. This improvement in the policy's effectiveness can be attributed to better transmission through credit and asset price channels. Ininvestigating disaggregate inflation, we find that a contractionary monetary policy is more effective in reducing inflation in the manufacturing sector than in the agricultural sector. Further, the sacrifice ratios in allmanufacturing sectors have improved over time. However, the commodities prices of some sectors respond positively after a monetary contraction, which demonstrates the presence of acost channel in the Indian economy. Our findings suggest that the monetary authority in India should have an interest rate rule that incorporates sectoral inflation and reacts to each with different intensity.

Prof. Satyasiba Das Associate Professor Balakrishnan, R., & **Das, S.** (2020). How do firms reorganize to implement digital transformation?. *Strategic Change*, 29(5), 531-541. DOI: https://doi.org/10.1002/jsc.2362.

Abstract: The paper follows an explorative approach to digital transformation (DT), an organizational transformation achieved through digital technologies such as mobile technologies, social media, cloud, internet-of-things, big data analytics, and artificial intelligence. The study involving qualitative research on 14 technology-intensive firms, attempts to understand structural changes and managerial actions associated with DT. The study has found that medium and large-sized firms handle innovation and operations separately wherein the small firms build innovation into operations by embedding relevant skills in team members. The small firms focus on process innovation whereas the other firms

focus on both process optimization and new market offerings. The study has new findings on DT managerial actions that include organi zation-centric activities linked to employee engagement, external stakeholder-centric activities connected to partner engagement, and technology-centric activities related to achieving economies of scale.

Abstract: With the arrival of Big Data, organizations have started building data-enabled customer value propositions to increase monetizing and cost-saving opportunities. Organizations have to implement a set of guidelines, procedures, and processes to manage, process and transform data that could be leveraged for value creation. This study has approached the journey of an organization towards data-enabled value creation through four levels of data processing, such as data extraction, data transformation, value creation, and value delivery. This study has critical inferences on using data management solutions such as RDBMS, NoSQL, NewSQL, Big Data and real-time reporting tools to support transactional data in internal systems, and other types of data in external systems such as Social Media. The outcome of this study is a methodological technology independent data management framework an organization could use when building a strategy around data. This study provides guidelines for defining an enterprise-wide data management solution, helping both the academicians and practitioners.




