Following Terms & Conditions are mutually agreed by IIM Raipur and (National Insurance company Limited).

- 1)IPD Cover for 5 Lac SI on floater basis for(77 primary + 176 Dependents) 253 members.
 - 2)This will be a cashless facility to be provided all over the country to the extent possible or as per the policy of the company. Reimbursement of expenses incurred by the insured will also be made, if the hospital is not listed for providing the cashless facility.
 - 3)Salient features of the group Medclaim Policy are as under:
 - a)EOI & Financial bid of the National Insurance Company will be internal part of this agreement (Annexure-I & Annexure-II) .
 - b)Family means Self, Spouse, Dependent children, Parents-in-law and siblings or as per the definition of dependency as prescribed for Central Government employee by Government of India.
 - c) Age Limit: Day 1 to 80 yrs are eligible to enter into the policy.
 - d) Room Charges payable
 - 1)Normal Room @ 2% of SI per day subject to maximum Rs. 10000/day
 - 2)ICU Charges @ 4% of SI per day subject to maximum 20000/day
 - d)Sum Insured: Rs.500000/- (Rupees Five Lakh Only) on floater basis.
 - e)Pre-Existing disease will be covered from day one in policy.
 - f)First 30 days and specific waiting period will be waived of.
 - g)No sub-limits or illness wise limit.
 - h)Pre & post hospitalization minimum 30 and 60 days respectively.
 - i)Maternity Benefit will be covered without any waiting period and subject to limit of Rs.- 25,000/- for normal delivery and Rs- 50,000/- for caesarean delivery.
 - j)New born baby should be covered since birth (Added at the time of renewal).
 - k)Day one cover for new member and their dependents.
 - l)Mid-term inclusion of existing employees newly acquired dependents (Newly married spouse/ New born baby/ Newly adopted child)
 - m)Corporate buffer of Rs. 10 lakh must provided (Restricted to Rs 2 Lakh per family for special cases referred by IIM Raipur.
 - n)Claim settlement period not exceeding 15 working days after submission of claim.
 - o)Cashless cards to all the members should be provided within one month of the start of the insurance cover.
 - p)All the settlements/Reimbursements must be carried out by the National Insurance Company Limited directly or through TPA. In case of any query by any member of the policy and official of the Institute, prompt response of the same by insurance company is expected.
 - 4)Addition and deletion of employee/member will be done on prorata basis. For deletions in case of retirement/completion of contract period /resignation/ death of employee or member. In case of deletion of employee, pro-rata refund for entire family to be done subject to NIL Claim. A floater account for the same will be maintained by the insurance company and the statement of the same will be provided to the Institute after each addition or deletion of employee or member.
